



PROMOTION refers to this specific “CIBC Caribbean and Visa FIFA World Cup 2026™” promotion offered by CIBC Caribbean Bank Limited, or its affiliates as applicable (“CIBC Caribbean”) wherein Eligible Cardholders earn chances to win prizes based on their Eligible Card usage (this “Promotion”).

This Promotion is subject to the following terms and conditions.

PROMOTION DURATION: Monday, March 16th 2026, to Thursday, April 30th, 2026, inclusive (“Promotion Duration”).

ELIGIBLE CARDS

This promotion applies to the following Cards, collectively referred to as “Eligible Cards”:

All CIBC Caribbean Visa Credit Classic, Silver, Rewards, Gold and Platinum cards.

Note: All other CIBC Caribbean Mastercard, Visa Debit, Visa Credit and Debit business and commercial cards are excluded from this promotion.

MERCHANT

A person in duly authorized possession of a Point-of-Sale (POS) terminal accepting the Eligible Cards.

ELIGIBLE TERRITORIES

This Promotion is offered only in The Bahamas, Barbados, The Cayman Islands

ELIGIBLE CARDHOLDERS

Person(s) holding one or more Eligible Cards with CIBC Caribbean (“Cardholder(s)").

Cardholders must be eighteen (18) years of age or older to be eligible to participate in this Promotion.

Cardholders whose credit card accounts are delinquent (those in arrears more than 30 days) shall not qualify as Winners. Entries from unauthorized cards used or made with lost, stolen, or fraudulent Cards are void and not eligible for this Promotion.

DRAW

One (1) Winner from each Eligible Territory will be selected. Each Winner will be invited to attend an in-country, in-branch prize handover ceremony. The prize ceremony will take place at a designated branch in each Eligible Territory. Winners will be required to confirm their attendance via email and participation in the ceremony in order to receive their prize. 2. CIBC Caribbean will make three (3) attempts to contact the participant between the hours of 8:00 am and 5:00 pm via the telephone at the number associated with the Eligible Card and one (1) attempt via the email address associated with the Eligible Card over three (3) business days.

Once contact is made successfully and the skill testing question is answered correctly, the participant has three (3) business days to confirm their acceptance of the prize by completing the contest release form and sharing a copy of their Passport, Driver’s License, or Voter’s identification (ID) via email. Without limiting the foregoing, CIBC Caribbean shall not be liable for any incidents occurring at hotels, venues or event locations, including but not limited to riots, crowd disturbances, stampedes, or other occurrences that may result in personal injury or death to the Winner and/or any travel companion.

20. CIBC Caribbean disclaims all responsibility for obtaining any travel visas, permits or other authorizations required for the winner and/or any travel companion to receive or enjoy the prize, including without limitation immigration, exit or entry requirements applicable to any country or territory. Compliance with all such requirements remains the sole responsibility of the winner and any travel companion.

21. In the event of a Force Majeure occurrence, CIBC Caribbean reserves the right, in its sole discretion, to cancel, suspend, modify, or terminate the Promotion or any prize, without obligation to provide compensation, substitution, or reimbursement to any participant or Winner.

Winners must be eligible for travel to the country in which the game is being held and must hold valid travel documents, including but not limited to a valid passport and where applicable, a valid visitor visa or other required entry documentation. 26. Proof of such documents must be provided prior to confirmation and public announcement of the final winners. CIBC Caribbean reserves the right to select an alternate winner if documentation is not provided or any of the criteria above is not met.

27. The Winner hereby agrees to take part in any publicity events, including photo opportunities at events arranged by CIBC Caribbean relating to this Promotion. If the Winner declines to participate in any publicity event, he/she will forfeit the prize.
